Mandatory Reporting and Confidentiality Requirement

The Older Adult Protective Services Act (DAPSA), which is liberally construed to ensure the availability of protective services, provides protection for abused, neglected, exploited, or abandoned adults over 60. It provides mandatory reporting procedures for imployees," that work at a "facility" as defined by the OAPSA. A voluntary reporting provi ion for those with reasonable cause to believe an older adult is in need of protective services is also included.



How this impacts advocates

Many advocates are likely mandlatory reporters under the GAPSA. Sexual assault comandatory reporters under the act. By statute, sexual assault advocates have an absolute privilege pertaining to communications between the victim and the advocate. It sexual assault advocates are subpoenaed regarding confidentia munications, they should file a motion to quash the subpoena unless the client provides written consent to

Sexual assault counselors should distinguish themselves from mandated reporters and inform clients that other advocates may be mandated reporters. Sexual assault courselors should discuss the pros and cors of making a report with the victim's written consent and explain the reporting process.
